Treasurer's Report, Becky:

Youth Update, Hank:

Picnic Update, Dean:

Stream Project Update, Larry:

- Call from fish commission 7/1. US Fish & Wildlife reviews all permits, Adams County concerned with mud bog turtles
- Easier to complete stream projects Oct 1- Mar 31, due to turtle hibernation; additional control measures will be required 4/1-9/30
- Permits expected from fish commission next week.
- Board needs to review and approve budget and the permits
- Recommendation to do backhoe work and repair existing mudsill on Knouse land
- Permits will be good for 5 years when approved
- Down trees need to be cleared; Dean to send available dates to the group for feedback
- Fish Commission GPS'd the stream; awaiting for return of the information; single map request

Youth Update, Dean:

- No requests for support this year to the conservation & fly fishing camp
- Unable to reach Quinton or Brantley for any updates; No longer members of the chapter
- Joe Whitmore is stepping down from a board member position at the end of the year but will continue to coordinate the SOY event
