KNOUSE PROPERTY-UPPER SECTION OF CATCH AND RELEASE

We continue with Conewago Task Force meetings for the betterment of fly fishing in Adams County. Our financial goal has not been reached, although does look attainable but we need your help. In our last newsletter, I spoke of how critical preserving this piece of stream property will be in the future for you the fly angler on page 10 in the last newsletter titled "Access Means Everything". Last year alone, we lost over 4 miles of excellent water on Little Marsh Creek being dropped from the stocking schedule.

A stream easement, if agreed upon, will be carried by the PFBC, giving us the same privileges under the regulated section of catch and release by following the PFBC guidelines. In this stream easement a parking and access area to the stream will be added when enough funds are secured for these additions.

This may be your chapters final cry to you to get involved and help make a difference. If you fly fishing this section you should recognize how critical preserving this waterway? Any amount will be cheerfully accepted. Without any help received your chapter needs to consider cutting more programs that requires cutting back on the annual budget including donations to other non profit groups to somehow be able to reach this agreement. The ABC's of Fly

Do you have any tips you'd like to share with others? Please send them to swopeda@hotmail.com Look for more hints each month.

What is the proper tippet size to use for the fly I am using? A great starting point that usually doesn't need any adjustment is by dividing the hook size by 3. If you are using a size 12, that would be a 4X tippet size. If the hooks size doesn't divide equally, round off to the nearest whole number (16 would be 5.33 so use 5X). You can also go a size heavier if the water is cloudy or high. Also, be sure to learn to tie a loop knot to attach a streamer pattern to your leader. It gives your imitation much more life-like motion and it is also a very strong knot, stronger than a standard clinch knot.

The seventh woman to become a Waterways Conservation Officer for the Pa. Fish and Boat Commission spoke at our last monthly meeting at the ACCD. Her name is Rachel Thurner Diaz. Rachel's regions to patrol and stock trout includes all of Adams County and parts of York County.

Her presentation was bringing the group of attendees up-to-snuff on what's new from the Fish and Boat Commission in 2020 including a trout stocking overview which includes stocking more rainbow and golden rainbows trout and less brook trout. After years of research, the PFBC believes more rainbows will survive and remain within the streams after stocking. Furthermore, the rainbows growth in a hatchery environment are much better and they can withstand acidic conditions more favorable. Also, Rachel added

that rainbow trout provide a better

fishing experience.

Although the fly fishing angler believes that the brown trout will last more into the fishing season because they are less likely to be caught after stocking.

No news on a fishing license increase after 14 years.

The chapter extends their appreciation for her speaking at our meeting.

TRI-COUNTY WATERSHED ASSOCIATION

The Tri-County Watershed Association Meeting was held at Shippensburg University for local watershed organizations and individuals in the South Mountain region of Adams, Cumberland, Franklin, and York counties. Watershed Specialists from Adams, Cumberland, and Franklin County Conservation Districts facilitated the meeting as part of the South Mountain Speakers Series.

The South Mountain Partnership is a conservation project in south-central Pennsylvania that hosts the South Mountain Speakers Series each year. The speaker series strives to educate and engage the public on contemporary conservation topics and challenges to create a citizenry that values and supports the preservation of the natural, cultural, agricultural, and recreational resources of the South Mountain region.

This meeting focused on connecting watershed associations to landowners and provided an opportunity for attendees to share an overview of their organization. Hank and Dave attended and represented ACTU. Dave presented an overview of ACTU's upcoming activities and events. Pennsylvania Organization for Watersheds and Rivers (POWR) will be organizing another regional water workshop for the South Mountain Speaker Series on March 27th, 2020 at the Trails and Trees Environmental Education Center in Mechanicsburg, PA.

In addition to the Speaker Series, the South Mountain Partnership coordinates a mini-grant program that is intended to catalyze on-the-ground projects that further the goals of the Partnership. The Mini-Grant program targets projects to sustain South Mountain's sense of place by protecting and promoting the region's Landscape Resources. The current priority project proposals are those addressing water resources, especially projects that bring many partners together to meet water pollution reduction goals by implementing watershed restoration projects. We look forward to continuing to develop our relationship and involvement between ACTU and the South Mountain Partnership

HEIDLERSBURG FISHING SHOW


