### 2015 Kids Fishing Derby By: Sue Cipperly

At 7:00 a.m. on May 2, members of the Yellow Breeches Anglers and Conservation Association (YBAC) arrived at the Latimore Fairgrounds with a truck full of trout, and eager young people helped ferry the trout to the creek in nets. They were preparing for the annual TU Kids Fishing Derby, which would begin at 8 a.m. After signing up at the registration table, excited children and their families set off to find a good fishing spot along the children's section of Latimore Creek. We had a total of 50 children participating this year.

At the sound of the air horn, the quest for the longest trout began, with shrieks of excitement as the young anglers landed their fish. For some, their TU Derby catch was the first time they had caught a fish. At 10:00 am, the air horn signaled the close of fishing, and volunteers measured the fish and recorded the length. The prize for the longest fish in each of 4 age groups was a choice of rods, and each participant got to choose from a selection of door prizes provided by the club and donated by area companies. The winners for longest fish were: Marques Flowers (age 4) 14" fish; Chance Reindehl (age 8) 13.5 " fish; Hunter Madara (age 10) 14.5" fish; Darien Osmun (age 11) 14 1/8" fish.

While the fishing was going on, TU members were cooking hot dogs -which the kids and their families enjoyed along with chips, drinks, and cookies. Everyone had a great time, and the weather was great for an event like this. Several families have made this an annual "must do" and have expressed their appreciation for the event each year. The fishing derby is free of charge to the participants, though there were several gener-

ous donations by the parents. The following companies and organizations donated goods or gift cards to support the event: Yellow Breeches Anglers and Conservation Association, the PA Fish and Boat Commission, Utz Potato Chips, Cadbury Schweppes, Giant Foods (Gettysburg), Weis Foods (Gettysburg), LL Bean, B&B Lures (Hanover), and the Adams County Conservation District. This morning of fun would not have happened without the dedicated folks from Adams County TU, who seem to have almost as much fun as the young folks. ## Comments To Change DHALO to C&RFFO for Big Cove Creek, Fulton County

As most fishermen know by now, the PAF&BC proposed changes to allow bait in the Delayed Harvest Streams has been pulled and cancelled. This, I believe, was made possible by fishermen's opposing comments who knew this would have been a bad idea. Now that the subject of "Special Regulation Stream Sections" is still on the forefront of the Commission, I am requesting all fly fishermen to provide individual comments on our Big Cove Creek (Delayed Harvest) stream section here in Fulton County. A year and a half ago a petition with nearly 200 signatures was sent to the Commission asking them to change the one mile section of Delayed Harvest Artificial Lure Only (DHALO) to Catch & Release Fly Fishing Only (C&RFFO). They put the decision off and have not done anything to even survey or look into the possibility of making a change to the regulation.

I am asking fly fishermen within our southcentral region to access the PAF&BC website. Just click on "The Fishing Hole" (<u>link</u>) and under suggested comments state that the DHALO section on Big Cove Creek, Fulton County, be changed to C&RFFO. The following rationale is a suggested example, if you would like to use it:

- Fish hold over even in drought years because of three cold limestone springs that feed into it.
- It has variety and abundant aquatic life to maintain good food and quality fishing.
- Good habitat provides the potential for trophy trout if not harvested.
- This section is an exception to most DHALO streams because it has excellent water quality and would be better designated as C&RFFO.
- Because of its high water quality and popularity it attracts fly fishermen from nearby Maryland, West Virginia and even Virginia.

You may want to reference your own experiences and why you would like to see it changed to C&RFFO. Even though petitions were submitted in the past, personal and individual comments may carry more weight to accomplish this request.

### Mr. Brown Trout By: Dave Swope

After the group finished trout stocking on the Conewago Creek and I finished the PFBC paperwork showing the number of stops in each of the three sections, how many people participated in the stocking, how many anglers fishing, etc. I managed to wet a line in open waters, where the angling pressure did not seem as great. My preferred fishing equipment has always been a fly rod, fishing a spinner fly gold variation. This type of fly rod spinner fishing is not for beginners. After landing a few trout and releasing them without touching the fish, I decided to move upstream in the faster current. With the water almost over my hip waders, I made a few casts, catching a fish almost every cast. On the next cast, I felt the fly stop and I flipped my wrist before the trout spit out the fly, the fish was on. For the next II minutes, with my fly line to the backing, I let the fish run and just fed the line out. I knew, as the fight progressed, that it was a brown trout. Never once coming to the surface, it fought extremely hard, strictly on the bottom.

Up stream and then downstream he fought, close to the far shoreline but never tangled in the debris on the other side. I managed to move downstream in lower water, but where the currents were stronger, to make sure I could recognize the size of the fish and when he would be ready for the landing net. I was hoping he would not start downstream over the rocks. I readied the net, as the fish came close, and was somewhat amazed at the size of the large dark spots on his body. Now, for the first time, viewed this monster brown trout and when he saw the net, round two of fighting occurred - but I could tell the battle wasn't the same. I managed to bring him in towards the stream bank to land. I knew without getting his tail end into the net far enough to lift him up was going to be quite a task, even though the fight was over. Finally, I had my chance with the major part of the tail end in the net to lift quickly. The brown trout was 24 inches and 6 lbs. My biggest brown trout ever. The trout is far ahead in the fishing contest and will be mounted next to the four rainbows, brown, and gold rainbow in my mancave. The trout will be mounted curving from out the TU national net the chapter presented to me years ago. It's a somewhat of a new engineering design that I have in mind.

A day later I landed a 18 inch, 3 lb brook trout. The largest I have ever caught and the biggest brookie in the fishing contest. Now what should I do?



## **ABC's of Fly Fishing**

Having trouble with your fly and leader landing in a heap? Two pointers to try: Think of a 3 foot level balanced on your casting shoulder—your hand should travel along the line of the level. Another thought: Think how you would spray someone with water if you held a paintbrush with the bristles loaded with water. You would start out slow so you wouldn't spray yourself, then gradually speed up your arm/hand and stop abruptly at the end of your reach directly at the person, not the ground. That is a beautiful cast in the making!

Also, fly patterns that have movement built into the fly materials suggest life and are great choices. Think rabbit, marabou, bear, squirrel, mink and muskrat for some of you flies.
